- **Homewares – vases, ornaments, kitchenalia, soft furnishings.**
- **Fashion – clothes, shoes, bags, accessories, jewellery, wedding attire and exclusive wear.**
- **Books – travel, fiction, kids.**
- **Entertainment – instruments, vinyl and more.**
- **Fitness equipment**

- **Bikes**

Items we cannot sell in Bolton Hospice shops:

We appreciate all donations but are unable to collect items we cannot sell that would require us to pay for disposal. We recommend avoiding making any related arrangements (e.g. for delivery of replacement items) before your collection has taken place.

- **Upholstered items that do not carry the appropriate fire label. It is a legal requirement that all upholstered items carry the appropriate fire label to meet British safety standards. Without the correct label we will be unable to accept your donation.**
- **Children's equipment:**
 - **Car seats**
 - **Cot/Moses basket mattresses**
 - **Soft toys without CE label**
 - **Baby gates**
 - **Baby walkers**
 - **Any item that suspends a child, i.e. swings, carriers**
 - **Safety helmets of any type**
- **Furniture and housewares:**
 - **Gas appliances, oil lamps**
 - **Cigarette lighters and cigarette lighter refill canisters**
 - **Knives and scissors**
 - **Fireguards**
 - **Hot water bottles**
 - **Fireworks**
 - **Inflatables of any type**
 - **Large wall units**

- **Fitted kitchens and bedrooms (unless a complete base unit new)**

- **Electrical items (all electric appliances must display the CE Mark):**
 - **Electric blankets**
 - **Electric showers**
 - **Sunbeds and tanning equipment**
 - **Power tools without instructions**
 - **Fridge/fridge freezer**
 - **Tumble dryers**
 - **Washing machines**
 - **Washer dryers**
 - **Electric fire with bars**
 - **Large back televisions**
 - **Printers/laptops/hard drive computers**
 - **Electric fish tanks**
- **Weapons:**
 - **Knives**
 - **Swords, sword sticks, crossbows**
 - **Guns and ammunition (including replica guns, unless obviously toys)**
- **Heating and cooking:**
 - **Gas appliances of any type (mains or bottled goods)**
 - **Oil filled radiators (not supplied with a thermostat)**
 - **Storage heaters (hardwired)**
 - **Oil and gas Agas**
- **Sport and safety equipment:**
 - **Buoyancy aids, life jackets, inflatable dinghies, inflatable toys for water**
 - **Safety helmets – riding hats, crash helmets, cycle helmets**
 - **Safety harness of any sort**
 - **Firefighting equipment**
 - **Roller blades, skates, skate boards**
- **Software and Hardware:**
 - **Home recorded DVDs, video and audio tapes**
 - **Home recorded computer games and software on recordable CDs and DVDs**
- **Miscellaneous:**
 - **Personal appliances, such as shavers, foot spas will be accepted as new or very good condition.**
 - **Medication, including vitamins**
 - **Perishable goods, food and drink**
